Empanelment Notice

- 1. National Institute of Design Assam is an Autonomous Institution of National Importance under Department for Promotion of Industry and Internal Trade (DPIIT), Ministry of Commerce and Industry, Govt. of India established at Jorhat through the NID (Amendment) Act, 2019 passed by the Parliament of India, invites proposals for "Empanelment of Contractors /Vendors for Civil (Repairs Maintenance, Interior works) and Electrical works" at NID, Assam Up to 5 lakh" from reputed firms for empanelment by NID Assam for a period of initially 2 (Two) years. The empanelment may be extended or reduced for a period decided by NID Assam, at the discretion of NID Assam, based on the firm's performance.
- 2. Proposal for the empanelment of contractors, are invited from the interested, firms/companies, who are in the business of construction, manufacturing, fabrications, service and maintenance of buildings, electrical installations, machineries all other specified jobs.

The Contractors are requested to Fill up the application forms as prescribed in the tender documents in closed envelope clearly mentioning in the top of the cover "Empanelment of Contractors /Vendors for Civil (Repairs Maintenance, Interior works) and Electrical works" at NID, Assam Up to 5 lakh' and submit along with all relevant documents during the time to The Director, National institute of Design, Assam, along with empanelment fees of Rs 10000/- (refundable after Two Years without any interest) The amount shall be paid by a demand draft drawn in favors of "Director, NID Assam", payable at SBI Garali, Jorhat, Assam.

Proposal Submission: The following set of documents needs to be submitted to qualify for the evaluation process. These documents are:

- 2. Form 1: Application
- 3. Form 2: Relevant Project Experience
- 4. Form 3: Details of responding organization
- 5. Form 4: Non-Black-listing Declaration.
- 3. The criteria and actual process of evaluation of the responses to this RFE and subsequent selection of the firm(s) will be as mentioned in this RFE and any modification or changes to the terms and conditions mentioned in this RFE will be entirely at the discretion of NID Assam.
- 4. No contractual obligation whatsoever shall arise from this Request for Empanelment (RFE) process unless and until a formal contract is signed and executed by a duly authorized official(s) of NID Assam with the selected firm(s). NID Assam reserves the rights/right to empanel more than one firm.
- 5. The content of this RFE enlists the requirements of the NID Assam. It includes the Empanelment Terms which details out all that may be needed by the firms to understand the terms and the empanelment process and explain the contractual terms that the NID Assam wishes to specify at this stage.
- 6. Interested agencies are advised to study this RFE document carefully before submitting their proposals in response to the Empanelment notice. Submission of a proposal in response to this notice shall be deemed to have been done after careful study and examination of this document with full understanding of its terms, conditions and implications.
- 7. Proposal for the empanelment of Vendors, are invited from the interested, firms/companies, who are in the business of construction, manufacturing, fabrications, service and maintenance of buildings, electrical installations, machineries all other specified jobs.

2. Scope of Work

NID Assam intends to empanel capable Civil, Repairs, Maintenance, Interiors and Electrical contractors for various works. The empaneled firms/contractors shall carry out the miscellaneous civil, electrical works Interiors works like brick /stone masonry, plastering, flooring, Wood work paving, aluminum works, MS fabrication works, waterproofing, painting, polishing, furnishing, furniture, electrical, sanitary & plumbing works etc. at the Campus of NID Assam located in Jorhat for various jobs that are required for day-to-day smooth operations of NID Assam.

Plumbing repairing/repair works /Cleaning works etc. Renovation work i.e., Supply and installation of vitrified tiles/antiskid tiles/ceramic tiles/sanitary fittings after removing existing tiles/ external & internal sewerage pipelines and any other repairing work involving Civil, Sanitary & Plumbing, Repair and making of office furniture viz. Office/ Executive Chairs, Tables, Cup Boards, Bookshelf, Sofa-sets, Podium cum computer stands, side tables, Compactors, cabinet locks, pedestals etc.
3.	Electrical	Electrical works including cabling works, wiring and connections, installation, and repair of lamps/electrical pump sets/motors/panels etc. HVAC, air conditioning work, Repair of Geyser, Refrigerator, washing machine etc. all other electrical equipment's. Repair and maintenance of overhead 11 KV HV conductor/ distribution line, transformers, Vacuum circuit breaker, and all electrical substation equipment's.

While the above-mentioned activities are to give an idea on the nature and type of work, there can be any additional activities of similar nature, which the empaneled firms/companies would be required to undertake, based on the requirements from time to time. The quality of the services is extremely critical and as part of their proposal the bidder/proposer should demonstrate core competencies/strengths on the above key aspects including adherence to quality and timely execution.

3. The following essential documents (whichever is applicable) should accompany with the registration form:

- 1. Trade License; Factory License.
- 2. PAN Card & GST Registration
- 3. Memorandum and Article of Association, Certificate of Incorporation, Partnership Deed, Registration Certificate issued by the Registrar of Firms etc.
- 4. Audited balance sheet or Profit & loss account for last three years.
- 5. Annual turnover certificate for last three years duly certified by a CA firm.
- 6. A notarized certificate that the vendor hasn't been blacklisted by any institution of the Central/ State government / any PSU, University, Institute etc. in the past three years should be submitted.
- 7. Institute may ask the registered vendor/contractor to submit any other certificate from time to time as it may deem fit.

Apart from above essential documents electrical contractor and service centers /authorized dealers must submit below documents.

- 1. For electrical work the relevant certificate is required/ Electrical license from authorised authority.
- 2. Current dealership agreement from Principal along with SSI/NSIC certificate if any.

General Terms and Conditions

- 1. The empanelment letter shall not confer any right to engagement. The contractor or its associates/companies who are empaneled with NID Assam as a result of this empanelment process are not allowed to use the name of NID Assam, its logo, service marks or any document for any purpose without the prior written approval of NID Assam.
 - 2. The Contractor must comply with the rules and regulations while registering for EPF, ESI and the Labour license etc. under the Contract Labour Rules and Regulation Act/any other rules or acts applicable for the above purpose.
- 3. NID Assam reserves the right to
 - a. Reject any / all proposals without assigning any reasons thereof.
 - b. Relax or waive any of the conditions stipulated in this RFP document as deemed necessary in the best interest of NID Assam and the objectives of the project without assigning any reasons thereof and
 - c. Include any other item(s) in the Scope of work at any time after consultation.
 - d. Empaneled additional agencies/ contractors at any time of the year.
- 4. **Blacklisting/debarring:** NID Assam reserves the right to cancel the empanelment letter issued and debar the firm, if it is discovered that the firm had produced any false information, on continued delivery of unsatisfactory services, insolvency of the company or any other ethical ground as deemed fit by giving a 7 days prior written notice.
- 5. **Allocation of work post empanelment:** The allocation of work post empanelment among all the empaneled agencies will be made by floating limited tender enquiries/nomination basis as and when the requirements arise.
- 6. During the evaluation, NID Assam may, at its discretion, ask the respondents for clarifications on their proposals. The firms/agencies are required to respond within the time frame prescribed by NID Assam.
- 7. NID Assam may at its sole discretion and at any time during the evaluation of the proposal, disqualify any respondent, if the firm:
 - i. Submitted the proposal after the response deadline.
 - ii. Made misleading or false representations in the forms, statements and attachments submitted in proof of the eligibility requirements.
 - iii. Exhibited a record of poor performance such as abandoning works, not properly completing the contractual obligations, inordinately delaying completion or financial failures, etc. in any project in the preceding three years.
 - iv. Submitted a proposal that is not accompanied by required documentation or is nonresponsive, failed to provide clarifications related thereto, when sought.
 - v. Was declared ineligible by the Government of India/State/UT Government for corrupt and fraudulent practices.
- 8. The application is liable to be rejected if:
 - i. Not in prescribed forms and not containing all required details.
 - ii. Not properly sealed and signed as per requirements.
 - iii. Received after the expiry of due date and time.
 - iv. Missing of any supporting document(s) with the Proposal.
